#### LE-04d

Electric energy meter, 3-phase, 2-tariff



Do not dispose of this device in the trash along with other wastel. According to the Law on Waste, electro coming from households free of change and can give any amount to up to that end point of collection, as well as to store the occasion of the purchase of new equipment (in accordance with the principle of old for-new, regardless of brand). ## Purpose

The LE-04d is a static (electronic) calibrated electricity meter of three-phase alternating current in a direct system.

The meter is adapted for cooperation with an external time clock and is designed for metering and billing in a 2-tariff system.

#### Functioning

A special electronic system under the influence of current flow and applied voltage in each phase generates pulses in proportion to the electricity consumed in this phase.

Phase energy consumption is indicated by flashing the corresponding LED (L1, L2, L3). The sum of the three phases of pulses indicated by a flashing LED is converted to energy taken in the entire three-phase system, and its value is determined by the segment LCD display.

Numbers after the decimal point indicate (.11 kWh =110 Wh). Separate displays T0 and T1 are used to indicate the energy consumption values of a tariff.

Switching between tariffs takes place when a control voltage is applied to the D input of the meter (terminals 10-11). An external timer can be used for this. The TO counter reads the energy consumption value when the control voltage is not applied to the D input.

T1 meter reads the energy consumed from the moment the control voltage appears at the D input until it disappears. The operation of the respective meter is indicated by illumination of the corresponding LED.

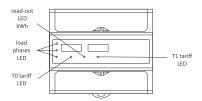

#### **Pulse output**

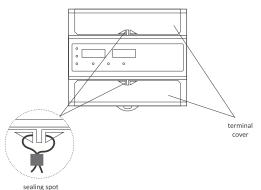
The indicator has a pulse output. This allows you to connect a pulse meter-reading (SO) pulses generated by the counter. For proper operation of the indicator is not required to connect additional devices.

# Sealing

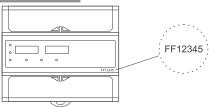
The meter has sealable input and output terminal covers to prevent any attempts to bypass the meter.



## Meter number

The meter is marked with individual serial number allowing its unambiguous identification. The marking is laser engraved and cannot be removed).

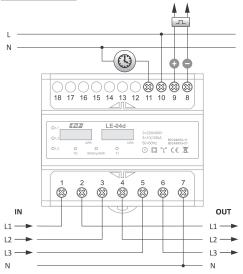

## Mounting

- 1. Disconnect the power supply.
- 2. The indicator mounted on a rail in the distribution box.
- Use a screwdriver to unscrew the screws and remove the front counter terminal covers.
- 4.Connect the voltages of the phases to be monitored as indicated to the terminals 1 (L1), 3 (L2), 5 (L3).
- 5. Connect the circuit to be measured or a single consumer to the terminals 2 (L1), 4 (L2), 6 (L3)
- 6. N-wire connect to terminal 7.
- 7.Additional pulse receiver connected (optional) to terminals 9(+) and 8(-).
- ! Additional pulse receiver is not required.
- 8. Connect the external timer to terminals 10-11.
- 9. Fit the meter terminal covers.

- 11 control timer (N)

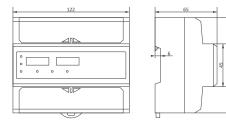
